I further agree to release indemnify, and hold harmless Alabama Cerakote and any of its affiliated organization and its employees from liability for any claims or damages of any kind that may arise from any work performed on my firearm, even if caused by negligence of Alabama Cerakote. Alabama Cerakote is not responsible for damage to any item stored on premises owned or operated by Alabama Cerakote, or caused by acts of God (tornados, flood, fire etc.)

I am informed, realize, and understand that any alterations which I have requested to be done to my firearm, pursuant to the Work Order, may release the Manufacturer from any liability for any accident that should occur. I am informed, recognize, and understand by reading and signing the Order Form, that by requesting that these changes occur, I am also releasing Alabama Cerakote, both individually and in any business form, from any liability should any accident occur because of the work performed by the gunsmith.

The Customer will indemnify and defend Alabama Cerakote from all liability for any loss, damage or injury to persons or property arising from or related to the performance of the agreement including, without limitation, all consequential damages whether or not resulting from the negligence of the Customer or Customer's agent.

Unless other arrangements are made, in writing, any jobs left in the shop for more than 90 days after written notification of job completion (via phone or mail) and request for payment of balance will be considered abandoned and may be sold to cover expenses. After 90 days from notification your items are considered "abandoned property"
